1.9.1. Incomplete. **2.2. EFFECTIVE -DATE, DURATION, TERMINATION OF THE AGREEMENT:**

2.2.1. The Agreement shall be effective from the date of acceptance of the offer as shown in the letter of acceptance of offer and award of work issued to contracting agency and shall remain in force for a period of One Year dated 01'April 2021 to 31 March 2022 from the said date.


2.2.2. The Agreement shall be deemed to expire on completion of the period, as provided in para 1.8.1 unless extended by both the parties.

2.2.3. During the tenure of the agreement, parties hereto can terminate the agreement either for breach of any of the terms and conditions of this agreement or otherwise by giving a two months' notice in writing to the defaulting party. Failure of either party to terminate the agreement on account of breach or default by the other shall not constitute a waiver of that party's right to terminate this agreement.

2.2.4. In this event of termination of the agreement vide provision 2.2.3 the right the obligations of the Parties thereto shall be settled by mutual discussion; the financial settlement shall take into consideration not only the expenditure incurred but also the expenditure committed by indenting office.
